TABLE OF FEES: made by Yoxford Parish Council acting as Burial Authority in respect of Yoxford Cemetery. Approved by Full Council on 7th September 2023.

Double Fees: Double fees will apply for all non-residents when purchasing the Interment Fee (Part 1) and the Grant to Exclusive Right of Burial (Part 2), however:

- if the resident has been required to move out of the area for example, for medical reasons or to a nursing home due to ill health, then a single fee (for Part 1 & Part 2) up to a 5 year limit would apply;
- if the resident has been required to move out of the area for example, for medical reasons or to a nursing home due to ill health and has family already buried in the cemetery then a single fee (for Part 1 & Part 2) would apply.

Proof of previous residency and date of move would be required by Yoxford Parish Council.

It is the responsibility of the family or Funeral Director to provide this information, failure to do so will result in the payment of double fees.

NB: The Parish Council has the discretion to take account of individual circumstances and will make a decision on the fees as appropriate.

A. In the graves for which an exclusive right of burial has been granted:

Part 2 – EXCLUSIVE RIGHT OF BURIAL FOR A PERIOD OF 99 YEARS IN AN EARTHEN GRAVE:

In a site selected in rotation

Part 3 – WALLED GRAVES AND VAULTS:

For the right to construct and for the exclusive right of burial for a period of 99 years in a walled grave or vault

By arrangement only

Part 4 – MONUMENTS:

For the right to erect or place in or on a grave or vault in respect of which an exclusive right of burial has been granted:

| • Kerbstone surrounds single plot (two plots side by side charged as two single plots) | £150.00 |
| This fee includes the first inscription – For each inscription after the first a further fee is payable | £10.00 |
| Memorial replacement/removal | £40.00 |
